ORDER

Whereas, it has been made to appear to me that 02 nos. Sectionalizing Valve Stations (SVS) and 01 no. Intermediate Pigging Station of GAIL in Kokrajhar district are required to be declared as “**Prohibited Area/Protected Area**” due to its national interest:

- And -

Whereas, the SV Stations are very hazardous in nature as gas-filled pipelines are passing through it, any sabotage may cause extensive damage to the installation and its surrounding area;

-And-

Whereas, the recommendation has been received from the Senior Superintendent of Police, Kokrajhar to declare these 02 nos. Sectionalizing Valve Stations (SVS) and 01 no. Intermediate Pigging Station as “**Prohibited Area/Protected Area**”;

-And-

Therefore, taking into consideration the vulnerability for mishap of these SVSs and IPS and the requirement of safety measures thereof, and looking into the greater public interest and in the interest of safety and security, it is extremely expedient to take up and ensure special precautions in order to regulate entry of unauthorized persons into the areas specified in the scheduled below except bonafide public servants/employees of Gas Authority of India Ltd. (GAIL);

After careful consideration of the above, I, Shri Pankaj Chakravarty, ACS, District Magistrate, Kokrajhar, Assam in exercise of the power conferred upon me under section 8E of Assam Maintenance of Public Order Act, 1947 as amended by the Assam Maintenance of Public Order (amendment Act, 1960, Assam Act XXXII of 1960) & U/S 163 BNSS, declare the following Sectionalizing Valve Stations and Intermediate Pigging Station of Kokrajhar District as “**Prohibited Area/Protected Area**”.
